AS PART OF THE TRANSITION PLAN, IT WAS CLEARLY COMMUNICATED AND UNDERSTOOD BY MANAGEMENT THAT THE PRIOR ACCOUNTING FIRM WOULD FILE THE NECESSARY FORM 8868, APPLICATION FOR AUTOMATIC EXTENSION OF TIME TO FILE AN EXEMPT ORGANIZATION RETURN, TO SECURE THE STANDARD 6-MONTH EXTENSION TO MAY 15, 2026. THE ORGANIZATION RELIED ON THIS PROFESSIONAL ENGAGEMENT IN GOOD FAITH. UNFORTUNATELY, DUE TO AN ADMINISTRATIVE OVERSIGHT AT THE PRIOR FIRM DURING THE TRANSITION OF RECORDS, THE EXTENSION WAS NEVER FILED WITH THE IRS. MANAGEMENT WAS UNAWARE OF THIS FAILURE, OPERATING UNDER THE REASONABLE ASSUMPTION THAT THEIR DESIGNATED TAX PROFESSIONALS HAD EXECUTED THE ROUTINE EXTENSION AS AGREED. THEREFORE, THE IRS RECEIVED THE COMPLETED INFORMATIONAL RETURN WITHIN THE TIMEFRAME THAT WOULD HAVE BEEN COMPLETELY STANDARD HAD THE PRIOR FIRM EXECUTED THE ADMINISTRATIVE STEP OF FILING THE FORM 8868. ESTABLISHMENT OF REASONABLE CAUSE HABITAT FOR HUMANITY OF THE RIVER VALLEY RESPECTFULLY ASSERTS THAT PENALTIES SHOULD BE ABATED FOR THE FOLLOWING REASONS: -RELIANCE ON A TAX PROFESSIONAL: THE ORGANIZATION ENGAGED QUALIFIED TAX PROFESSIONALS AND REASONABLY RELIED ON THEM TO FILE THE NECESSARY EXTENSION. MANAGEMENT EXERCISED ORDINARY BUSINESS CARE AND PRUDENCE BY ENSURING A TRANSITION PLAN WAS IN PLACE, BUT COULD NOT FORESEE THE PRIOR FIRM'S FAILURE TO FILE THE EXTENSION DOCUMENT. -NO WILLFUL NEGLIGENCE: THE FAILURE TO SECURE THE EXTENSION WAS AN INADVERTENT ERROR CAUSED BY A TRANSITION BETWEEN ACCOUNTING FIRMS, NOT A DELIBERATE DISREGARD FOR TAX LAWS OR IRS DEADLINES. -PROMPT CORRECTIVE ACTION: THE ORGANIZATION ACTED IMMEDIATELY UPON DISCOVERING THE OVERSIGHT, FILING THE RETURN PRIOR TO THE ANTICIPATED EXTENDED DEADLINE. -HISTORY OF COMPLIANCE: HABITAT FOR HUMANITY OF THE RIVER VALLEY HAS A STRONG HISTORY OF TIMELY FILING AND COMPLYING WITH ALL IRS REGULATIONS. FURTHERMORE, THE ORGANIZATION HAS A CLEAN COMPLIANCE HISTORY FOR THE PRECEDING THREE TAX YEARS AND QUALIFIES FOR FIRST-TIME PENALTY ABATEMENT. CONCLUSION BECAUSE HABITAT FOR HUMANITY OF THE RIVER VALLEY ACTED WITH ORDINARY BUSINESS CARE AND PRUDENCE, AND BECAUSE THE DELAY WAS SOLELY THE RESULT OF AN ERROR BY THE PRIOR ACCOUNTING FIRM DURING A PROFESSIONAL TRANSITION, WE RESPECTFULLY REQUEST THAT ANY LATE-FILING PENALTIES FOR THE TAX YEAR ENDING JUNE 30, 2026, BE FULLY ABATED.
